Subject: Requirements of the EU Packaging Regulation (Reg. (EU) 2025/40 – PPWR) and packaging-related conformity documents

Dear Sir or Madam,

Thank you for your inquiry regarding the requirements of the EU Packaging Regulation (PPWR) and the corresponding conformity documentation.

We confirm that we fully take into account the provisions of the PPWR, which will become mandatory as of August 12, 2026. The regulation introduces extensive obligations, including conformity assessment procedures, technical documentation, and EU declarations of conformity for packaging.

In this context, we are pleased to assure you that the packaging materials we utilize already comply with all statutory requirements today. This explicitly includes the stricter provisions of the PPWR that will not become legally binding until the year 2030.

Please note, however, that the harmonized standards and implementing acts required on the EU level for official certification are currently still being finalized. Consequently, specific documents formatted strictly in accordance with the PPWR are not yet available for all packaging types at this time. We are engaged in a continuous implementation process with our partners and packaging suppliers.

As soon as the official PPWR-compliant documents become bindingly available, we will promptly forward them to you as far as possible.
